An uneasy feeling about the investigative work about an unexplained cause of death of the child Jamil in the "care" of the German „Jugendamt“.

Jamil's mother, eldest daughter and sister and the assistant Anna Weber brought evidence to the Cologne police today.

After the conversation with police officer Düppen, all three women have a more than uneasy feeling about the objective death investigation.

The mere reference to the fact that the biological mother has no rights at all to her son, but that the official guardian alone could have decided whether the organs may be removed from the abducted child Jamil, does not necessarily show the tactful consideration for the suffering mother and the relatives. The "state" omnipotence of the German „Jugendamt“ even over the unexplained death of a child in the area of responsibility of the German „Jugendamt“ and the audacity to be able to decide on the child's organs without involving the biological mother, belongs [to the original German intellectual brutalization of a war criminal like Dr. Josef Mengele](#), who also thought that he was allowed to carry out his experiments with abducted Jewish children.

We are allowed to do everything – stay quiet! The police officer's argumentation indicates that the state obviously believes that even a dead child still belongs to the serfdom of the state or the German „Jugendamt“ and that one can therefore also afford not to apply the normal standards of a death investigation procedure in accordance with the rule of law when establishing the truth, for example. **The systemically relevant halo of innocence and always wanting to be right**

strikes through here with such malice that every civilized person loses his hearing and sight.

The ordinary mortal rubs his eyes at such an argumentation of the nomenklatura compared to the constant warning against the so-called "right-wingers" in direct relation to the relived "gray time"

Criminal Code (StGB) § 221

(suspension)

The law is clear: Anyone who puts a person in a helpless situation or abandons him in a helpless situation, even though he has him in his care or is otherwise obliged to assist him, and thereby exposes him to the risk of death or serious damage to his health, is punished with imprisonment of three months to five years.

The low point of brutalization.

A moral low point to the mother's suffering is the truly arrogant announcement of this "investigator" that the mother is only allowed to sign a declaration of silence from the doctors pro forma, but of course the "rights" over the child would only lie with the German „Jugendamt“ Bergisch Gladbach anyway. Allegedly, the

boy's body has already been released, after less than two days in the Cologne forensic medicine. Not to the mother - but to the German „Jugendamt“ Bergisch Gladbach - quite obviously for an organized criminal cover-up, the relatives suspect. But since when is a corpse endangered by the child's well-being?

. Why the child was brought to the hospital with shortness of breath is of "no interest at all" to the investigating officer. Here the mother had to refer to a visiting video in which the payment power of the German „Jugendamt“ fabricates – **"he did not give the child any sleeping pills today so that the boy would be fitter"**. 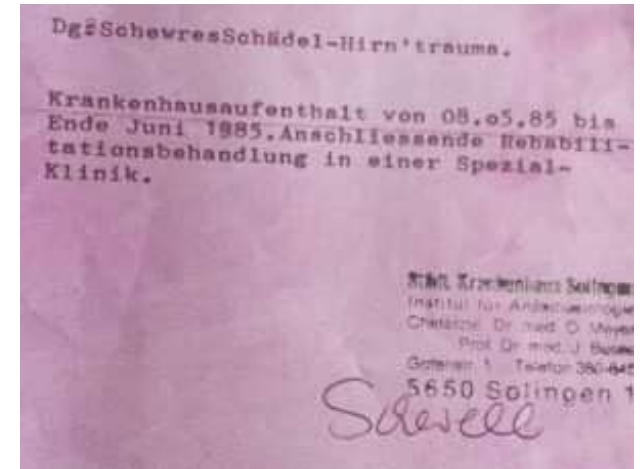
The main focus – state cover-up! Many observers of this affair had warned of it days ago.

In the course of her life, she raised 3 children until the 4 younger ones were abducted from her by the Bergisch Gladbach German „Jugendamt“, then represented by a remedial educator in women's clothes Timo Henrichs, in 2021 and the misfortune and suffering began. 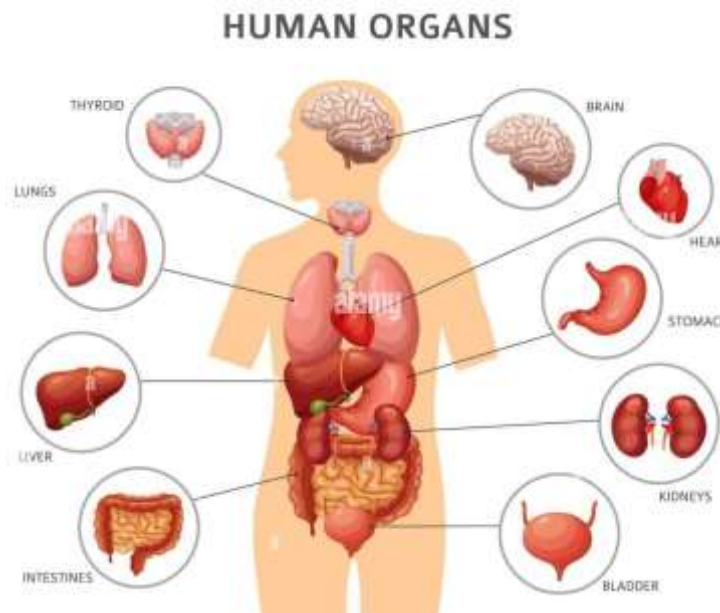

because the boy was "always so excited after the visits of the parents" and actually the mother is the only one to blame for the death of the boy. The woman, who was allegedly unattached and irresponsible to her children, had insisted so vehemently on her right to visit. The fact that this child was snatched from the mother as a premature baby even after 3 weeks – will certainly no longer play a role for this alleged "constitutional state".

. And because she didn't want it – her son died all of a sudden. Now the guardian is apparently in a hurry to have the body brought underground, as well as the fact that the devices were

turned off on 11.05.2024. Because the investigating officer also informed those present at the end that it will either already be released or will be released soon. At this point, too, the officer's statements do not seem entirely conclusive, as the doctors of the clinic had previously done to the mother. On 07.05.2024, Jamil had allegedly suffered complete organ failure, as well as brain death, and on 10.05.2024 the organs were suddenly supposed to have been ready for organ donation for survival after all? As reported, the mother is said to have been asked

When the mother asked the investigating officer, it was not enough to set the phone to "silent", no, it had to be switched off.

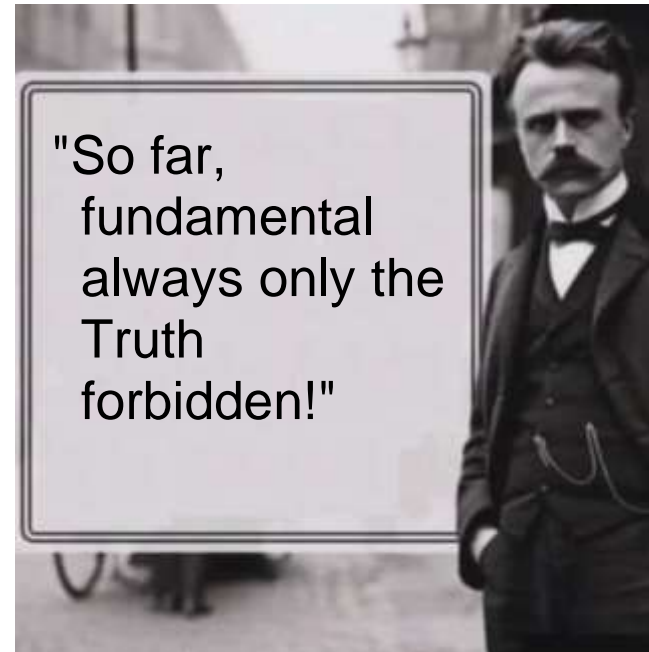
