Klinikum Leverkusen and the Bergisch-Gladbach „Jugendamt“ are stopping mechanical ventilation for child Jamil Haddad. Against the will of the mother! Was it a death from sleeping pills?

The fact that the Leverkusen Municipal Hospital simply turns off mechanical ventilation for the child Jamil Haddad over the weekend without the biological mother, only with the payment staff of the Bergisch Gladbach „Jugendamt“, must have criminal consequences. Observers of this entire scandalous case of the abduction of children from the household of the child's parents Haddad consider this "active" act, namely the switching off of the ventilator, as murder to cover up the actual circumstances of the child's death in the "care" of the „Jugendamt“ Bergisch Gladbach.

Remarkable was a statement by the police, who had been called the day before, after a call from concerned relatives and an assistant, informed the vigil participants after a conversation with the senior physician on duty that there would be no shutdown because the child was still alive and certainly not without the consent of the biological mother. A complaint for "unexplained circumstances of death" could not yet be filed because the child was in a coma, but

still alive, it was said at the request of a journalist by police officers investigating on site.

At around 12 noon yesterday, 11.05.2024, the assistant learned that the Cologne/Leverkusen criminal investigation department had been called in after all. After that, the life-sustaining measures are abruptly switched off without a court decision and without informing the mother.

If the doctor and caregiver, in this case the guardian Albrecht, agree that the termination of life-sustaining measures corresponds to the patient's wishes, this can also be done without the involvement of the guardianship court. **If the doctor or even the biological mother vetoes it, the court must decide.** Regardless of this, anyone can turn to the guardianship court and, in this particular case, to the family court.

Here are the reasons for the urgent decision:

Reasons:

The applicant is the mother of the child Jamil Driss, born on 24.04.2022.

The applicant has no parental custody of the child.

The guardian for the child Jamil Driss is the Bergisch Gladbach City „Jugendamt“ - Mrs. Albrecht-Cologne.

The child has been at Leverkusen Hospital since Tuesday morning due to illness. The applicant is not allowed to visit the child because the respondent or guardian does not want this. The applicant is also not sufficiently informed about the situation or condition of the child. The child is said to be in an artificial coma because it has shortness of breath.

The applicant wants to be with her child and is not allowed to.

I/we affirm the above information under oath, after I/we have been instructed about the meaning and criminal consequences of an intentionally or negligently false affidavit.

The doctor has certified a non-natural cause of death or, in ignorance of the patient's medical history, an unexplained cause of death. According to the law, the criminal investigation department is now obliged to initiate a death investigation.

Here is an investigative approach

Why the child could have died becomes clear from this little video. The mother asks Peter's payer why her child is in such a bad mood. Peters replies that I didn't give him – meaning the child – any sleeping pills today – so that he would be a little fitter. Are the sleeping pills the reason for respiratory arrest? And why did the child need sleeping pills at all? Because it was snatched from its mother as a premature baby? At the very beginning of the video, you can see a red spot on the cheek. Where does it



The Leverkusen Clinic is a filthy old building.

The death investigation procedure includes a thorough examination of the deceased and the premises, as well as investigations in the personal environment and, in particular, the clarification of the medical history and questions about the attending physicians.

The investigations are necessary to rule out possible third-party negligence in the death of your relative.

The actual cause of death is not determined in every case.

Why, this happened yesterday on 11.05.2024 - before the mother - who was on her way to the hospital - arrived in the intensive care unit - points to an organized cover-up according to all the circumstances of criminological experience - as the editors were informed. The mother, who

some time later was "allowed" to see little Jamil, who was now dead by the hands of the doctors in safe agreement with the Bergisch Gladbach „Jugendamt“ with an urgent decision of the Bergisch Gladbach family court – for whom she had waited eight hours a day earlier – was forbidden by the clinic to take her mobile phone with her to take photos. This new "order" of the „Jugendamt“ in slavish compliance by the Leverkusen Clinic alone indicates a suppression of evidence and possible intention to obstruct justice. The Bergisch Gladbach „Jugendamt“ does not dare to talk to the biological mother - obviously in misjudgement and usual justifications - "this is a risk to the child's well-being". In



In many comments on social media, it is then also assumed that all the "actors" in this matter have something to cover up.

The clinic is too cowardly to talk to the relatives – but without their knowledge to send a child to its death on an obvious mission.

On TikTok and other social media, the sympathy of the population is extremely high.

Currently, there are 56,800 views, 1158 likes and several heartbreaking comments – within less than 24 hours, while the so-called "suffering media" have so far and usually remained silent. [The editorial team had written to WDR and other local media.](#)
