On this day, the relatives are more likely to think of the two-year-old boy Jamil Haddad, who died under strange circumstances in the "care" of the „Jugendamt“ and its payers "Peters". Meanwhile, this scandal is known to hundreds of thousands of social media users, even though the "official" media deliberately conceals it. Not only the abuse scandal in the city of Bergisch Gladbach, but also this „Jugendamt“ scandal will go down in the city's history and shape the negative image. Especially because of this silence of a relevant event, an official scandal.

As I said before; Days before, there had been tough disputes with the Bergisch Gladbach court, the „Jugendamt“, the

responsible alleged child welfare officers, whether at least 13-year-old Younes – a self-confident Muslim boy (kept in Catholic home education – and then also with the children's home name "Maria Schutz" in Overath) – would be his dead brother, like almost all close relatives at the traditional washing on Saturday 25.05.2024 and at the open coffin

on Tuesday 28. 05.2024 but also at the important prayer in the mosque in Bergisch Gladbach.



**At a Muslim funeral, the imam says the funeral prayer for the deceased. In the coffinless burial, the corpse, wrapped in linen, is placed on its back on the ground, the head is turned slightly towards Mecca. The undertakers place wooden boards over the body, the imam explains to the journalist on site. Prayed on the back and the child's head was placed against Mecca.**

**For quite some time, the mourners at the children's grave site say goodbye to a large part of the Muslim children's cemetery Cologne-Brück. The relatives say that now he can play freely with other children and has his peace from the „Jugendamt“ and alleged "parents" who are not.**

For this purpose, it is important to know that the Muslim funeral is initiated even before the actual death occurs. Together with the dying person, the profession of faith is recited. This was forbidden to all family members – autocratically decided by the „Jugendamt“. **The mother had to queue for eight hours in front of the Bergisch Gladbach family court to get to her dying child by urgent order - and only for half an hour a day.** If death occurs, the deceased must be buried on

the day of death, which, as is well known, was not possible - as it is an unexplained death. **The child was transferred to the Cologne forensic medicine for an autopsy.** After the ritual washing and the prayer for the dead, the deceased is wrapped in linen cloths. If the children or siblings are not detained at the „Jugendamt“, this is always possible for all relatives. But the oh-so-German pedagogical staff has always had this Muslim farewell out of "alleged concern for the well-being of the child", whether the 13-year-old boy and the little siblings could cope with it, about the meaning-distorting German exuberant welfare of children of course and self-evidently not allowed. The children were probably not supposed to know that their little brother had died in the "child's welfare care" of these hypocrites of the „Jugendamt“ and then preferred to go home to their mother very quickly – where there was no danger to their lives, although they were always told by these Pharisees of the administration that staying with their mother was too dangerous for them. Only – everyone – even the children – know it – Jamil would have survived there.

It was clear to all participants in the conversation that the mendacious had no begging staff – instead of letting the 13-year-old go alone to the grieving family. Interesting – alone after Cologne, he is allowed to travel undressed.

On the day of the Muslim funeral in Cologne, which this brave boy Younes was then "allowed" to attend accompanied by two adult home

minders, many family members asked themselves whether it would not have been more appropriate if these "**mendacious pseudo-care managers**" had taken more care in the selection of the caregivers in advance when they transferred the power of disposal over the deceased child to these persons on behalf of the Bergisch Gladbach „Jugendamt“.

The famous Pütz/Roth funeral home in Bergisch Gladbach really took care of all funeral matters and the fact that all relatives were able to say goodbye on several days in a reverent manner and with great understanding for the suffering mother. Even the imam was full of praise, because Muslim funerals are rather the exception at this institute. What moved the imam very much was that the responsible employee was able to alleviate the mother's great suffering with great human feeling. were willing honorary helpers – for example, the "expert" beer brewer, who sucked devastating death sentences out of his finger for a lot of money and is directly responsible for the death of Jamil. When he was asked what he thought of it – **he** immediately hung up – like the original German "didn't know anything" – not only to the journalist, but also to the adviser Anna Weber, the mother Lamia Haddad and another activist who asked questions. We know this – from the **unsuspecting Germans** – who never claim to have known anything – **but have gone through everything** – like this vassal of the system, this corpulent Hans Hermann Bierbrauer is one, as are people who had to do with him.

Brigitte Brenner from Cologne – as the children's paid professional guardian – is now also benefiting from the whole abduction number, although alternative proposals have always been submitted to the so-called family court. For example, family members – but no – others earn stupid and stupid money from the suffering of a large family, if the children are in other "German" hands – today you can say – until death – which no one wants to take responsibility for. And no one wants to know anything anymore – and the mother is now supposed to deal with everything herself – although the errand, even simple problems, had always been denied to the mother by "expert opinion".

But who is the caregiver who was at the service of the Bergisch Gladbach „Jugendamt“ for a fee? It is the Peters family. She lives in the

countryside, several kilometers from the center of Odenthal. Between Kürten-Bechen and Altenberg Cathedral at the end of the small town of Odenthal. It is a staunchly conservative area. For decades, the CDU ruled in the Odenthal and above all in the Rheinisch-Bergisch district.

The Bergisch compatriots are said to be a cheerful people who lived without coercion and usually have a 'thirsty' liver. As genuine Bergisch people, many of them were friends of singing." This is how *Heinson* characterized "the grinders" in 1959. The fact that they were nature lovers, that some of them liked to take their rifles with them on the forest and heath walk and came home with animals shot to death, is also not a legend. Considerable parts of society were open to the new Nazi regime. The Rhenish population also accepted the destruction of the rule of law and democracy in part with approval and largely passively. Many looked at the "Third Reich" with certain hopes, and even among those who had not voted for the NSDAP in March 1933, not a few were soon willing to grant the new regime a "chance to prove themselves".

Today's administrative authorities have always taken strict action against the people of the Bergisch and still do. The immediate neighborhood assumed that Jamil was also an adopted son.

. The caregiver had treated Jamil Haddad lovingly, as well as with the six-year-old adopted son. He always carried him in his arms and kissed him and played with him. The caregiver often drove a tractor with Jamil and the boy was really happy.

## **A mini camera also at the entrance to the house - Everything attached to the child's well-being?**

She does not know what happened on the evening of 06.05.2024 to 07.05.2024, says a neighbor. Whether an accident car with an emergency doctor was there was also not. She had heard that the couple had driven the child to the Leverkusen hospital themselves. On

the Internet, she saw that the caregiver had given the boy sleeping pills. An older woman told us during the research that it had gone around the village like wildfire - that the little boy was dead. You shouldn't do something like that – administer sleeping pills – she explained shocked. This can often lead to respiratory arrest in children, according to the inhabitants of the village of Neschen.

Everyone wonders why the nurses drove Peters, the only two-year-old child Jamil Haddad, to the hospital themselves. Why was no emergency call made and an ambulance with an emergency doctor called to the child? Many also wonder how it could come to a final respiratory arrest and the boy could die from it - and that in the care of the wife - who is said to be a doctor or employee of a clinic.

Has she not made any attempts to resuscitate her? Why was the Leverkusen Clinic approached, because other hospitals would have been much closer. From the Peters' home to the Leverkusen Clinic it is an 18-minute drive (14.2 km) to the Evangelical Hospital Bergisch Gladbach, 15 minutes (10.8 km).

Since the wife is presumably supposed to work as a doctor or employee in a clinic - one does not understand at all in the village of Neschen that she did not call a specialist colleague. Because she is said to be working at the Cologne-Merheim Clinic, a renowned hospital. This indication has not yet been confirmed. It is also strange that the Peters have not been seen in the village for about 14 days. The couple are said to have travelled - even though the criminal investigation department is officially investigating an unexplained cause of death after a complaint by vigil participants in front of the Leverkusen Clinic on 10.05.2024. That is, since the time when the photo of Mr. Peters was published by our editorial team and on social media to get

more information about this man. We wanted to know how this terrible tragedy could have happened and why such professional mistakes were made in the care of the dying Jamil.

Nevertheless, a neighbor confirms that Peter's caregiver was deeply saddened by the boy's death - incomprehensible why he did not come to the funeral.
